
# **INCOME TAX ASSISTANCE**

# VOLUNTEER INCOME TAX ASSISTANCE (VITA)

VITA provides free income tax assistance to low-income people filing forms 1040, 1040EZ or 1040A. Assistance is provided from February through April of each year by appointment. Participants should bring all the necessary papers with them. Please call for an appointment.

Volunteers are needed to provide VITA services in Floyd, Montgomery & Pulaski Counties and the City of Radford.
